

# Liverpool rout Atalanta

## Real Madrid and Bayern Munich garner full points

Jürgen Klopp has made no secret of his admiration for Atalanta's all-out attacking game.

Perhaps because it's similar to the way his Liverpool squad pours forward with speed and precision, often overwhelming its opponents.

In the first-ever meeting between the two teams, Klopp's side was the one doing the overwhelming in a 5-0 rout of last season's surprise quarter-finalist in the Champions League on Tuesday.

Portugal striker Diogo Jota scored a hat trick to take his tally to seven goals in 10 matches across all competitions since joining Liverpool in September.

Mohamed Salah and Sadio Mané also found the net for the 2019 champion, which strengthened its control of Group D with a full nine points.

Elsewhere on the third match day of the group stage, 13-time champion Real Madrid beat visiting Inter

Milan 3-2 in Group B for its first win in this season's competition courtesy of a late goal from Rodrigo.

Defending champion Bayern Munich got late goals from Jerome Boateng, Leroy Sane, Robert Lewandowski

and Lucas Hernandez in a 6-2 win at Salzburg to preserve its perfect start in Group A.

Manchester City also stayed perfect with a 3-0 victory over Olympiakos in Group C with goals from Feran Torres, Gabriel Jesus

and João Cancelo.

In another rout, Borussia Mönchengladbach beat Shakhtar Donetsk 6-0 in Group B to match its biggest European Cup away win.

Ajax and Porto also won, while Lokomotiv Moscow

and Atlético Madrid drew 1-1.

In all, there were 35 goals across the eight games - two shy of the record for one day.

Both teams observed a minute's silence for the victims of an attack in Vienna on Monday.

In Moscow, Atlético opened the scoring with a header by José María Giménez but Lokomotiv equalized with a penalty kick converted by Anton Miranchuk after video review determined there was a handball.

Bayern leads Group A with nine points, Atlético has four; Lokomotiv has two and Salzburg one.

Inter, which remained winless, could at least celebrate the night's most beautiful goal, which featured Nicolò Barella's flicked through ball to set up Lautaro Martínez's finish in one swift motion.

The home win moved Madrid out of last place in Group B.

Borussia Mönchengladbach leads the group with five points after its rout of Shakhtar; one more than Madrid and Shakhtar.

## Hockey resumes in Tamil Nadu, Puducherry

Hockey players in Tamil Nadu and Puducherry have resumed limited sports activities in accordance with the Ministry of Home Affairs (MHA) guidelines amid the Covid-19 pandemic.

In Tamil Nadu, while there are several restrictions due to the ongoing battle with the pandemic, about 65 players have returned to the field. These players are above the age group of 18 years and are training towards the state championships which will be a trial for the Hockey India National Championships.

"We have been cautious in our approach to begin activities in Tamil Nadu and have resumed only limited training for a small group of players across different centres. Since all schools and colleges are closed only SDAT headquarters play fields in the districts are open," said Sekar J Manoharan, President of Hockey Unit of Tamil Nadu.

## THIS DAY, THAT YEAR

**1988:** Birth of a man who starred in two World Cups for India before he turned 23. Virat Kohli captained the Under-19 side to the title in Malaysia in 2008, and in 2011 stood alongside Tendulkar and Co in Mumbai, having scored a crucial 35 in the final of the real thing (and a century in the opening game). In his first seven years of ODI cricket, Kohli scored 23 hundreds, ten of them in chases. He was picked in the Test side in June 2011. By the time Dravid and VVS Laxman had retired in 2012, India had one young batsman fit to replace them in the middle order. Kohli impressed everyone when he scored his maiden hundred in Adelaide, India's only century of the 2011-12 series. At the same venue in 2014, in his



first Test as captain, he made twin hundreds in a loss. He became the full-time Test captain towards the end of that series when MS Dhoni retired and the limited-overs captain in 2017. Kohli won his first full Test series 2-1, in Sri Lanka - India's first series win in that country in 22 years. Later in 2015, he became the fastest in the world to 1000 runs in T20 internationals, and a few months after that the fastest in the world to 7000 runs in ODIs. The form rubbed off in Tests too - between July 2016 and July 2017, he averaged 67.04, converting four of his six hundreds into doubles. Kohli went to England in 2018 with the spectre of a horror tour from four years ago looming large. He made 139 runs in five Tests in 2014; this time he made 593, propping up India's batting single-handedly, but they still lost 4-1. But he made up for that with India's first series win in Australia six months later. In 2019, Kohli became India's most successful Test captain and made his career-best score - 254 against South Africa in Pune.

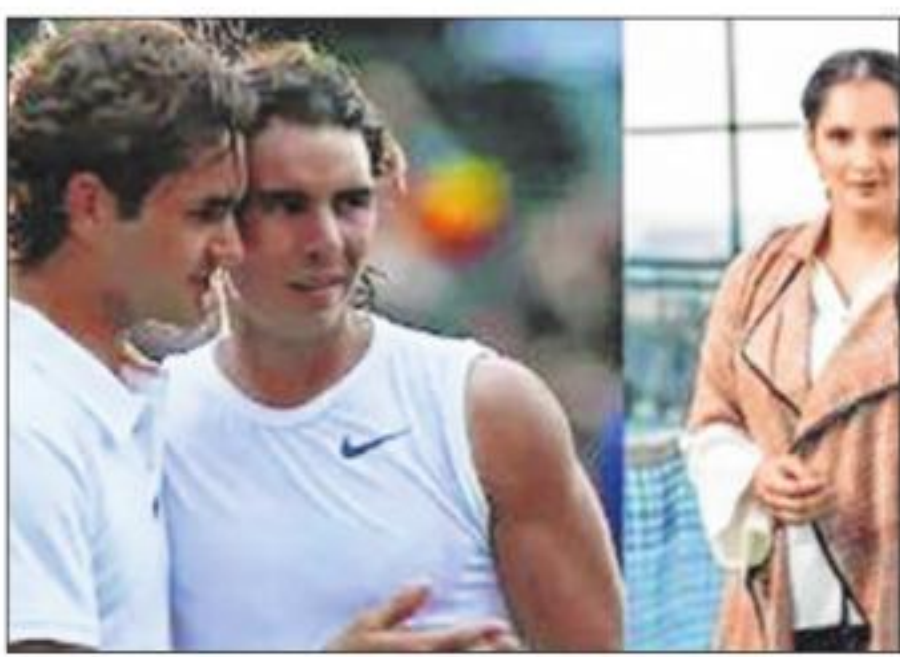
The 20-year-old is the only player from
